- Dressage Championship High Score Prizes & Ribbons will be awarded to the AA, Jr/YR, Open SCDCTA Member / SCDCTA Reg. Horse Pair with the highest score. Combined Training Championship Low Score Prizes & Ribbons will be awarded to the AA, Jr/YR, Open SCDCTA Member / SCDCTA Reg. Horse Pair with the lowest score.

**Attire:** An ASTM Approved helmet must be worn AT ALL TIMES when mounted and footwear should have a distinguishable heel while riding. Otherwise, casual attire is acceptable.

**Arenas:** A (20m x 40m) dressage arena will be used for all CT Dressage, USEA TOC, and Introductory Level Dressage tests. A (20m x 60m) dressage arena will be used for the Training Level through FEI Dressage, Dressage Seat Equitation and Leadline classes. A separate outdoor jumping arena will be used for combined test stadium rounds.

**Musical Freestyle (MFS):** Music can be tested on Saturday, Oct. 21st at 4pm at the SCEP. Please email your music as a .wav or .mp3 file. Musical Freestyle tests will be USDF 2023 tests. Intro MFS will use the Training Level MFS USDF test.





**Non-Competing Horses:** Horses <u>NOT</u> entered in classes but attending the show must have a completed entry form (for each horse) by the closing date (10/15/23) and a current negative EIA-Coggins Report and EHV4-1 Vaccination Record (Dated within 6 months of show) submitted with the entry. The Entry Agreement must be signed by rider/handler of the horse. Each non-competing horse is required to wear a number when off the trailer or out of a stall.

**Grounds/Haul-ins**: This fee is assessed for all horses that are trailered in each day and do <u>not</u> have a stall reserved. Horses may **NOT** be tied to or left in trailers overnight.

**Office Hours and Fee:** The Office Fee pays for administrative costs that include numbers, dressage tests, programs, and daysheets. The office opens at 12:00 pm on Saturday, Oct. 21st and at 7:00 am on Sunday. The office will be closed at 6:00 pm on Saturday and closed on Sunday one hour after the last class is completed. All horses must be checked in and received a bridle number before being mounted or walked around the facility.

**Schooling and Lungeing:** Schooling may begin at 12:30 pm on Saturday, Oct. 21st. All horses are required to wear a bridle number when out of the stall whether being led, are mounted, or tied to a trailer. Lungeing is only allowed in the designated Lungeing area. Lungeing is not allowed in the warmup arenas. Competition arenas may be used on Saturday afternoon.

No horses are allowed in the competition arenas (Dressage and Jumping Sunday before the show starts and during the competition. Warmup arenas for both dressage and jumping will be designated and may be used anytime Saturday and Sunday.

**Scratches from Show / Classes:** Scratches on or before the closing date (Oct. 15th) will be refunded in full. No refunds after the closing date. Scratches during the show must be reported to the office before the ride time.

**Class Changes:** Classes can be added and changed before and during the show depending on the schedule. Requests to add or change classes before the show should be emailed to <a href="mailto:carol@scdcta.com">carol@scdcta.com</a>. During the show class adds or changes should be requested in person at the show office.

**Ride Times and Stall Assignments:** Times and stabling assignments will be emailed to the email address on the entry form by 10/18/23. Please contact the show secretary, Carol Freligh, <a href="mailto:carol@scdcta.com">carol@scdcta.com</a> or 843-857-6229 if you have questions. Stabling requests should be noted on the entry. Extra shavings may be purchased for \$8.00 by indicating the number on the entry or requesting additional shavings during the show.

**Stabling:** All stalls have been refurbished and have full rubber matting. Requests to stable with a group should be indicated on the entry form. Other specific stabling requests (for example: Stallion needs an end stall) should be indicated on the entry form.

**RV Hookup:** There are 50- and 30-amp RV sites. Any cord connected will be considered a hook-up per SCEP management and will be charged as an RV Hookup.

**Oktoberfest Schooling Show Sunday:** These classes are open to <u>ALL</u> competitors and SCDCTA membership is NOT required.

### SCDCTA Schooling Show Championship Classes Eligibility Requirements:

- Rider and horse must be eligible for 2023 SCDCTA Schooling Show Year End Awards. (Volunteer hour requirements are <u>not</u> required to enter Championship classes.)
  - Dressage 3 Tests (1 must be from the highest test of the level). Tests should be from two different judges.
  - Combined Training 3 CTs with two of the CTs from different judges.
- A rider/horse pair can compete and become eligible in both Dressage and Combined Training.
- Eligibility requirements may be completed during the Oktoberfest Schooling Show classes.
- SCDCTA membership and lifetime horse registration will be accepted through the closing date (October 15<sup>th</sup>). Memberships and/or horse registrations for the championship classes will **not** be accepted after October 15<sup>th</sup>. NO EXCEPTIONS.





### **SCDCTA Schooling Show Championship Class Rules:**

- 1. Similar to USEA and USDF Championship Rules with the exception that a reader is allowed. Whips are not allowed.
- 2. All horses must have a bridle with a bit. Bitless bridles and hackamores are not allowed. Double bridles are only allowed in Dressage at Third Level and above.
- 3. The horse may not wear boots or wraps in the dressage test, to include the CT dressage test.
- 4. A third error in a dressage test, or the horse steps out of the arena, or the horse falls (either shoulder touches the ground) or rider falls is cause for elimination.
- 5. In the jumping phase of CT, a third refusal, or fall by the horse (either shoulder touches the ground) or rider falls is cause for elimination.
- 6. Both in Dressage and Jumping, the judge may eliminate a rider for concerns associated with safety of the rider or horse.
